## UNDERSTANDING THE PATH TO U.S. CITIZENSHIP

Becoming a United States citizen is a life-changing milestone that grants permanent residents the right to vote, obtain a U.S. passport, and fully participate in American civic life. ## ELIGIBILITY REQUIREMENTS FOR NATURALIZATION

## Age and Legal Permanent Resident Status

You must be at least 18 years old at the time of filing Form N-400, the Application for Naturalization. Additionally, you must have been a Lawful Permanent Resident (LPR) – that is, a green card holder – for a specific period. Generally, most applicants must have held LPR status for at least five years. If you are married to a U.S. citizen, the required period is reduced to three years, provided you have lived in marital union with your citizen spouse for that entire time.

## Continuous Residence and Physical Presence

The **M 476 A Guide To Naturalization** places significant emphasis on the concepts of continuous residence and physical presence. Continuous residence means you have not abandoned your residence in the United States during the required period. Extended trips abroad (typically six months or more) may break continuity. Physical presence refers to the actual number of days you have been inside the U.S. during the required period; for a five-year applicant, you must have been physically present for at least 30 months (913 days) out of the five years immediately before filing.

To calculate your physical presence, the guide recommends using a travel history log or the USCIS online calculator. Keep copies of your passport stamps, flight itineraries, and entry/exit records as evidence.

## Good Moral Character

USCIS requires applicants to demonstrate good moral character for the statutory period (usually five years, but three if married to a citizen). Certain criminal offenses, fraud, or dishonesty can disqualify you. The guide lists specific bars, such as convictions for aggravated felonies, drug trafficking, or murder. Even if you have a minor infraction, it is wise to consult an immigration attorney or a trusted legal aid organization. The guide also includes information about how to obtain certified court documents if needed.

## English Language and Civics Knowledge

Unless you qualify for an exemption or accommodation, you must be able to read, write, and speak basic English. You will also need to pass a civics test covering U.S. history and government. The guide includes a full list of the 100 civics questions from which the test is drawn. Many applicants find it helpful to study using the USCIS official study materials, which are referenced in the guide. Exemptions are available for certain older applicants and those with medical disabilities; proper documentation is required.

### THE APPLICATION PROCESS: STEP BY STEP

---

Once you confirm your eligibility, the next phase is filing your application. The **M 476 A Guide To Naturalization** provides a detailed walkthrough of each stage, from gathering documents to attending the interview.

## Step 1: Complete Form N-400

Form N-400 is the core of your naturalization application. You can fill it out online through your USCIS account or submit a paper version. The guide includes tips for each section, such as how to list your addresses, employment history, and trips outside the U.S. Accuracy is critical; mistakes or omissions can lead to delays or denials. Take your time reviewing the instructions, and consider having a second person check your answers.

## Step 2: Prepare Supporting Documents

Along with your completed N-400, you must submit evidence of your eligibility. This typically includes a copy of your green card (front and back), passport-style photographs (if applying by mail), and any requested documentation about marriages, divorces, or name changes. The guide includes a checklist of required documents for each applicant category. If you are applying based on your marriage to a U.S. citizen, you will also need evidence that you lived in marital union, such as joint leases, tax returns, or bank statements.

## Step 3: Pay the Fees and Submit

The current filing fee (subject to change) includes both the application fee and a biometric services fee. Fee waivers or reduced fees may be available if you meet low-income guidelines. The guide explains how to apply for a fee waiver using Form I-912 and what documentation to attach. After paying, submit your application and wait for a receipt notice (Form I-797C) from USCIS.

## Step 4: Biometrics Appointment

Several weeks after filing, you will receive a notice for a biometrics appointment at a local Application Support Center. At this appointment, USCIS will take your fingerprints, photograph, and signature. The **M 476 A Guide To Naturalization** reminds applicants to bring the appointment notice and a valid photo ID. Biometrics are used to run a background check through the FBI.

## Step 5: The Naturalization Interview and Test

This is the most anticipated stage. You will be scheduled for an interview at a USCIS field office. During the interview, a USCIS officer will review your application, ask you questions about your background, and test your English and civics knowledge. The guide suggests preparing by practicing the civics questions with a friend or using flashcards. Arrive on time, dress professionally, and bring all original documents you submitted copies of, as well as your green card and any updated evidence.

The English test includes a reading portion (pronouncing a sentence correctly) and a writing portion (writing a sentence dictated by the officer). For the civics test, you will be asked up to 10 questions from the list of 100; you must answer 6 correctly to pass. If you do not pass the first time, you will have a second opportunity to retake the test within 60 to 90 days.

## Step 6: Decision and Oath Ceremony

If the officer approves your application, you will be scheduled for an Oath of Allegiance ceremony, usually on the same day or within a few months. At the ceremony, you will take the oath, receive your Certificate of Naturalization, and officially become a U.S. citizen. The guide explains that you may be able to request a name change at the time of the interview, though this can sometimes delay the process. It also notes that you should not travel internationally with your naturalization certificate until you obtain a U.S. passport, as the certificate is not a travel document.

### COMMON CONCERNS AND HOW TO ADDRESS THEM

Many applicants have questions about topics not fully covered in the basic eligibility summary. The **M 476 A Guide To Naturalization** addresses these special situations.

## Applicants with Military Service

Men and women who have served honorably in the U.S. armed forces may be eligible for expedited naturalization and reduced residency requirements. The guide includes a special section for military

members, explaining how to file using Form N-400 while on active duty or after release. It also covers provisions for spouses of military members who died during service.

## Medical Disability Exceptions

If you have a medical disability that prevents you from learning English or civics, you may qualify for an exemption. The guide details how to submit Form N-648, Medical Certification for Disability Exceptions, along with a licensed medical professional's statement. The disability must be physical, developmental, or cognitive, and it must affect your ability to fulfill the testing requirements.

## Applying for Child Citizenship

Naturalized citizens often want to ensure their children also acquire citizenship. The guide explains the Child Citizenship Act of 2000, which automatically grants U.S. citizenship to certain children born outside the U.S. when specific conditions are met, such as having at least one parent who is a U.S. citizen and the child residing in the U.S. as a lawful permanent resident. In some cases, you may need to file Form N-600 to obtain a Certificate of Citizenship for your child.

## What Happens If You Are Denied

A denial can be disheartening, but it is not always the end of the road. The guide outlines the appeals process, including how to request a hearing with an immigration officer (Form N-336). It also encourages applicants to seek legal counsel if the denial involves complex legal issues. Common reasons for denial include failure to meet residency requirements, criminal history not fully disclosed, or failing the tests despite retaking. Understanding why you were denied is the first step toward a successful reapplication.

### PRACTICAL TIPS FROM THE GUIDE
