PRINCIPLE 4: PEOPLE RESPOND TO INCENTIVES

Incentives are rewards or punishments that influence behavior. When the price of a good rises, consumers tend to buy less, and producers tend to supply more. This principle is the engine of market economies. Mankiw uses vivid examples, such as seatbelt laws and their effect on driving behavior, to illustrate that people adjust their actions based on the incentives they face. PRINCIPLE 5: TRADE CAN MAKE EVERYONE BETTER OFF
