- Brush your teeth, gums, and tongue for at least two minutes using a fluoride toothpaste.
- Floss to remove any particles between teeth.

- Use an alcohol-based mouthwash (like Listerine) to kill bacteria and possibly reduce metabolite levels. Some people recommend a 30-second rinse, then spit.
- Scrape your tongue with a tongue cleaner to remove biofilm that may hold drug metabolites.

## 4. Detox Mouthwashes and Chewing Gums

Keep in mind that many detox products have unproven claims, and laboratories are aware of common masking agents. Using them may increase the chance of a sample being flagged as altered.

# Synthetic Saliva Substitutes

Some people attempt to replace their own saliva with a synthetic saliva product. This involves hiding a small amount of fake saliva in the mouth and then providing that sample during the swab. This method is risky because:

- The observer may notice the substitution.
- Temperature must be correct (around 96°F or 35.5°C).
- Synthetic products are not always chemically

identical to human saliva, and labs can sometimes detect the difference.

Given the high stakes, this approach is not recommended unless you are experienced and confident in the product's quality.

## 6. Timing the Test to Your Advantage

If you have some control over when the test is administered (such as a pre-employment screening), schedule it for as late in the day as

possible. This gives you extra hours to hydrate, eat, and clean your mouth. Also, try to schedule it after a meal, as eating can stimulate saliva flow and may help flush metabolites.

### WHAT DOESN'T WORK: MYTHS TO AVOID

---

Several popular internet strategies are ineffective or even harmful when trying to pass a mouth swab test. Avoid these:

- **Vinegar or lemon juice:** These acidic substances can irritate your mouth and may be detected as adulterants.
