Strategies for Part 3: Representation, Practices, and

Procedures

Part 3 is unique because it tests your understanding of how to interact with the IRS on behalf of clients. Start by thoroughly reading Circular 230, which is the foundation of ethical practice for EAs. Focus on the rules regarding client confidentiality, conflicts of interest, fees, and advertising. Also, study the procedural aspects of IRS audits, appeals, and collections. Understand the hierarchy of IRS authority, including the role of the Taxpayer Advocate Service, and know the differences between various types of IRS notices and correspondence. Practice scenarios where you must determine the appropriate response to a client request

or an IRS inquiry. Role-playing these situations with a study partner can be very effective for this section.
