AND ANATOMY OF THE SKIN

You Must Know for the Milady Chapter 8 Test

You need to know the skin inside and out—literally. The chapter introduces the three primary layers of the skin: the epidermis, dermis, and subcutaneous layer. For the Milady Chapter 8 test, pay special attention to the epidermis. You will be expected to identify the five layers of the epidermis (stratum corneum, stratum lucidum, stratum granulosum, stratum spinosum, and stratum germinativum) and understand what happens in each. Key cells to memorize include:

THE STRUCTURE

- **Keratinocytes:**

The majority of epidermal cells, responsible for producing

keratin, a fibrous protein that waterproofs and protects the skin.

- **Melanocytes:**

Cells that produce melanin, the pigment that determines skin color and protects against UV radiation.

- **Langerhans**

Cells: Immune cells that help fight infection.

- **Merkel Cells:**

Sensory cells involved in the sensation of touch.

blood vessels and the production of sweat, the skin helps maintain body temperature.

3. **Absorption:**

While the skin is a barrier, it can absorb certain substances, which is why topical products work.

4. **Protection:** The skin is the body's first line of defense against bacteria, chemicals, and UV radiation.

5. **Excretion:** The skin eliminates waste products through sweat.

6. **Secretion:** Sebum is secreted to lubricate and protect the skin and hair.

Understanding these functions is not just academic; it directly impacts how you choose products and perform services.

SKIN TYPES AND CONDITIONS

A massive portion of the Milady Chapter 8 test focuses on identifying skin types and conditions. You will need to distinguish between:

- **Normal Skin:**

Well-balanced, with fine pores and a healthy glow.

- **Oily Skin:**

Overactive sebaceous glands, leading to shine, enlarged pores, and a tendency toward acne.

DISORDERS AND DISEASES OF THE SKIN

This is often the most challenging section of the Milady Chapter 8 test because it requires memorizing many new terms. You will need to differentiate between primary and secondary lesions. Knowing when to recommend a client see a physician is a critical skill tested in this chapter. For example, if a client presents with a lesion that has an asymmetrical shape, irregular border, uneven color, or a diameter larger than a pencil eraser (the ABCDEs of melanoma), you must refer them to

a doctor.

Proven Study Strategies for the Milady Chapter 8 Test

5. MNEMONIC DEVICES
