UNDERSTANDING THE MEANING OF REFLECTION IN MATH

REFLECTION OVER THE X-AXIS

For example, the point (4, 5) reflected over the x-axis becomes (4, -5). Imagine flipping a shape upside down; that is exactly what this reflection does.

REFLECTION OVER THE Y-AXIS

Reflecting over the y-axis changes the sign of the x-coordinate while keeping the y-coordinate unchanged. The rule is $(x, y) \rightarrow (-x, y)$. For instance, the point (4, 5) becomes (-4, 5). This is like looking at a shape in a vertical mirror placed along the y-axis.

REFLECTION OVER THE LINE $y = x$

This reflection swaps the x- and y-coordinates. The rule is $(x, y) \rightarrow (y, x)$. So, the point (4, 5) becomes (5, 4). Visually, this reflection flips a shape over the diagonal line that runs from the bottom-left to the top-right of the coordinate plane.

REFLECTION OVER THE LINE $y = -x$

Reflecting over the line $y = -x$ also

swaps the coordinates but also changes their signs. The rule is $(x, y) \rightarrow (-y, -x)$. So, the point $(4, 5)$ becomes $(-5, -4)$. This is a less common but important transformation that combines both swapping and sign changes.

REFLECTION OVER THE ORIGIN

Reflecting over the origin is equivalent to rotating a figure 180 degrees. It changes the sign of both the x- and y-coordinates. The rule is $(x, y) \rightarrow (-x, -y)$. The point $(4, 5)$ becomes $(-4, -5)$. While technically a rotation, it is often taught alongside reflections because it follows a simple coordinate rule.

How to Perform a Reflection on a Graph
