WHAT EXACTLY IS A HEDGE FUND? A SIMPLE BREAKDOWN

However, the data shows that the average hedge fund does not consistently outperform a simple, low-cost index fund like the S&P 500, especially after accounting for fees. This has led to a wave of criticism against the industry. The key takeaway is that hedge funds can be a powerful tool for diversification, but they are not a

magic bullet. You must do your due diligence on the fund's strategy, track record, risk management practices, and fee structure before investing a single dollar.
