LEGAL REQUIREMENTS FOR A VALID CALIFORNIA TRUST

DEED

To be accepted for recording by any California County Recorder's office, the Trust Transfer Grant Deed must meet strict requirements. A fillable form helps ensure compliance, but you still need to understand the essentials.

Notarization Is Mandatory

California law requires that all grant deeds, including trust transfer deeds, be notarized. The notary public must verify the identity of the grantor(s) and

witness the signing. **TRANSFER GRANT**

The notary will also affix their official seal and complete an acknowledgment, which is essential for recording.

Proper Legal Description

A street address is not sufficient. The deed must include the full legal description of the property as it appears on your current title. This description can be found on your existing deed, a previous title report, or your property tax bill. An incorrect legal description is one of the most common reasons for rejection by

the county recorder.

Assessor's Parcel Number (APN)

Including the APN on the deed is not technically mandatory, but it is strongly recommended. Most county recorders use the APN for indexing and cross-referencing. Including it helps ensure accurate recording and simplifies future title searches.

Document Transfer

Tax Affidavit

An important nuance of the Trust Transfer Grant Deed is the documentary transfer tax. When property is transferred into a revocable living trust, the transfer is generally exempt from this tax because it is not a change in ownership. A completed Preliminary Change of Ownership Report (PCOR) must typically accompany the deed to claim this exemption. The fillable form version of the deed often includes a section for documenting this exemption.

Filling out this form requires careful attention to detail. Here is a step-by-step guide to completing each section correctly.

Step 1: Identify the Grantor

The grantor is the current owner(s) transferring the property into the trust. Enter your full legal name(s) exactly as they appear on the current deed. If you are married and own the property jointly, both spouses must be listed.

Step 2: Identify the Grantee (Trustee)

The grantee is not you personally; it is the trustee of your living trust. Write the trustee's name and the trust name exactly as stated in your trust document. For example: "John A. Smith, Trustee of the Smith Family Trust dated March 15, 2024." It is crucial to include the date of the trust because many trusts are amended, and the

recorder needs to identify the specific iteration.

Step 3: Provide the Real Property Descripti on

This section is where many people stumble. The legal description is block of text that precisely describes the property boundaries. Copy it exactly from your existing deed or title policy. Do not paraphrase. Include the lot, block, tract number, and any accompanying references. Below the

legal description, add the street address and the Assessor's Parcel Number for the recorder's convenience.

Step 4: Complete the Documen tary Transfer Tax Section

In this section, indicate that the transfer is exempt from documentary transfer tax because it is a transfer to a revocable living trust. The typical

wording is: "This transfer is exempt from documentary transfer tax pursuant to California Revenue and Taxation Code Section 11911." Fill in zero dollars (\$0.00) as the tax amount. If you are unsure, consult the specific exemption codes for your county, as some counties have slightly different requirements.

Step 5: Sign and Notarize

Sign the deed in the presence of a notary public. Do not sign it beforehand. The notary will complete the acknowledgment, which includes the date, location, and their official seal. All

grantors must sign. If a spouse is not on title but the property is community property, some counties still require their signature to release any potential community property interest. Check with your local recorder.

COMMON MISTAKES TO AVOID

Even a small error on a Trust Transfer Grant Deed can cause delays or rejection. Here are the most frequent pitfalls.

Mismatched Names

The name on the deed must match the name on the current title

exactly. If your current deed shows "Robert M. Johnson," do not write "Bob Johnson" on the trust transfer deed. Any discrepancy can trigger a title issue later.

Incorrect Trust Name

The trust name must be stated exactly as written in the trust agreement. Even a missing comma or incorrect date can cause recording problems. Always double-check the trust document.

Preliminary Change of Ownership Report

Most counties require a completed PCOR to be submitted with the deed for reassessment exclusion purposes. Without it, the county assessor might reassess the property for property tax purposes, potentially increasing your tax bill. Even though transfers to a revocable trust are generally excluded from reassessment

under Proposition 19, the paperwork must be filed correctly.

Recording at the Wrong County

Record the deed in the county where the property is physically located, not where you live. If your property is in Los Angeles County but you reside in Orange County, the deed must go to the Los Angeles County Recorder.

RECORDING THE TRUST TRANSFER GRANT DEED

Once the deed is notarized and the PCOR is completed, it is time to record the

document with the County Recorder's Office. Recording gives constructive notice to the world of the transfer. You can record in person, by mail, or electronically if your county offers that option. Recording fees vary by county but typically range from \$30 to \$50 per page plus additional fees for indexing and mapping. After recording, the county will return the original recorded deed to you. Keep this document with your trust paperwork. It is the proof that the property is now held in the trust.

What Happens

After Recording?

Once the deed is recorded, the property title is legally transferred to the trust. You will continue to live in and manage the property identically. The trust now owns the property, but as the trustee, you control it. Your property tax bill stays the same (since it was a non-reassessment transfer). Your homeowners insurance and mortgage should ideally reflect the trust as the owner or an additional insured. Some lenders may require notification, but your existing mortgage terms generally remain unchanged because

the transfer is to a trust where you remain the borrower.

DO YOU NEED AN ATTORNEY TO PREPARE A TRUST TRANSFER GRANT DEED?

While the fillable form makes the process accessible, preparing a deed without legal guidance carries risks. A single error in the legal description or the trust name can invalidate the transfer. If your estate plan is complex, you have multiple properties, or you have specific goals such as creditor protection or blended family planning, consulting a California estate planning attorney is strongly recommended. The cost of correcting a defective deed later can far exceed the

initial legal fee. For straightforward situations, many people successfully complete the form themselves, but careful adherence to every requirement is essential.

Yes. Transferring title to a revocable living trust does not trigger the "due on sale" clause in most mortgages, provided you continue to live in the home and make payments. This is allowed under the Garn-St. Germain Depository Institutions Act.
