# Clothing and Footwear

Clothing was the most commonly donated item to The Salvation Army in 2012. The organization accepted gently used, clean clothing for men, women, and children. This included everyday wear, formal attire,

outerwear, shoes, boots, belts, hats, scarves, and handbags. Seasonal items like winter coats and boots were especially needed as colder months approached. Donors were encouraged to check for stains, tears, or missing buttons before donating, as items in poor condition could not be resold or distributed.

# Furniture and Household Goods

Furniture donations were highly sought after by The Salvation Army in 2012, particularly for families transitioning out of

homelessness or low-income households setting up their first homes. Accepted furniture included couches, chairs, tables, dressers, nightstands, bed frames, mattresses (in good condition with no stains or tears), and bookshelves. Small household items such as lamps, mirrors, picture frames, curtains, and kitchenware were also welcomed. Donors should note that large furniture items often required a scheduled pickup, as transporting them to a drop-off location could be challenging.

Working electronics and small appliances were accepted at most Salvation Army locations in 2012. This included televisions, DVD players, radios, small kitchen appliances like toasters and blenders, and even computers (though data wiping was recommended). Larger appliances such as refrigerators, washing machines, and dryers were accepted only if they were in good working order and met current energy efficiency standards. Donors were advised to call ahead to confirm acceptance of specific items, as policies could

vary by location.

## Vehicles

Car donations to The Salvation Army were a popular choice in 2012, offering donors a way to turn an unwanted vehicle into a tax deduction while supporting a worthy cause. The organization accepted cars, trucks, vans, boats, motorcycles, and even recreational vehicles, regardless of condition. Proceeds from vehicle sales directly funded adult rehabilitation centers and other community programs. The process typically involved a simple online form or phone call, followed by free towing from the donor's location.

## Books, Media, and Toys

Gently used books, CDs, DVDs, vinyl records, video games, and toys in good working order were accepted at most Salvation Army thrift stores. Educational materials were especially appreciated for after-school programs and literacy initiatives. However, donors were asked to avoid donating outdated textbooks, encyclopedias, or damaged toys, as these could not be resold and would incur disposal costs for the charity.

## **DONATE: THE SALVATION ARMY'S 2012**

### **GUIDELINES**

Knowing what not to donate was just as important as knowing what was accepted. A responsible Salvation Army donation guide for 2012 would include clear prohibitions to save both donors and staff time and effort. Items that were generally not accepted included:

- Mattresses with stains, tears, or visible wear (health regulations)
- Large appliances that were not in working order
- Paint, chemicals, or hazardous materials
- Used tires or

### **WHAT NOT TO** automotive parts

- Weapons or ammunition
- Food items (unless through a specific food drive partnership)
- Items with pet stains, smoke damage, or heavy soiling
- Cribs or car seats that did not meet current safety standards

When in doubt, donors were encouraged to call their local Salvation Army branch or consult the official website for a current list of accepted items. This small step could prevent frustration for both the donor and the charity.

### **HOW TO PREPARE YOUR DONATIONS**

## **DROP-OFF**

Proper preparation of your donations ensured a smooth process and maximized the value of your contribution. In 2012, The Salvation Army recommended the following steps:

1. **Clean and Sort All Items:** Wash clothing and linens, wipe down furniture, and ensure electronics are dust-free. Sort items into categories (clothing, books, housewares) to make processing easier for staff.
2. **Box or Bag Items Securely:** Use sturdy boxes or garbage bags for clothing and small items. Label boxes

clearly. **FOR PICKUP OR** possible. For furniture, ensure pieces are disassembled if needed for transport.

3. **Check for Personal Belongings:** Before donating, thoroughly check pockets, drawers, and compartments for personal items like wallets, keys, or cash. Staff reported finding valuables in donated items more often than one might expect.
4. **Prepare a Detailed Donation List:** For tax purposes, create a written inventory of all donated items



with estimated fair market values. This list would serve as your record for claiming a deduction on your 2012 tax return.

---

### **SCHEDULING A PICKUP IN 2012**

---

For large furniture, appliances, or multiple bags of clothing, scheduling a free pickup was often the most convenient option. In 2012, donors could call their local Salvation Army branch or visit the organization's website to arrange a pickup. Typical waiting times ranged from a few days to two weeks, depending on the season and location. Donors were asked to leave items at the curb or in a designated area

on the scheduled day, clearly marked as a donation for The Salvation Army. It was important to note that pickup services were available for items that could not be easily transported by the donor, but smaller donations were always welcome at any drop-off location.

---

### **TAX DEDUCTION GUIDELINES FOR 2012 DONATIONS**

---

One of the key motivations for donating in 2012 was the potential tax benefit. The IRS allowed donors who itemized deductions to claim the fair market value of donated goods to qualified nonprofits like The Salvation Army. However, proper documentation was critical. A comprehensive

Salvation Army donation guide for 2012 would emphasize the following points:

- **Get a Receipt:**

For any single donation valued at \$250 or more, a written acknowledgment from The Salvation Army was required. For smaller donations, a bank record or a written communication from the charity (such as a receipt) was sufficient.

- **Estimate Fair Market Value:**

The IRS defined fair market value as the price a willing buyer would pay for the item in its current condition. Thrift

store prices from The Salvation Army's own stores were a good reference point.

- **Use Donation Valuation Guides:**

In 2012, many donors relied on resources like the Salvation Army's own valuation guide or independent donation value guides to assign appropriate values to their items. For example, a used winter coat in good condition might be valued at \$15-\$25, while a functional dining table could be worth \$50-\$150.

- **Keep a Detailed List:**

written record that includes the date of donation, the name and address of the charity, and a description of each item with its estimated value. This list, along with your receipt, would support your deduction if the IRS ever asked questions.

It was also wise to consult a tax professional or refer to IRS Publication 526 for specific questions about charitable deductions in 2012. The rules could be nuanced, especially for high-value items like vehicles or antiques.
