WHO IS SALLY FROM THE CAT IN THE HAT?

When we think of Dr. Seuss’s timeless classic *The Cat in the Hat*, the first image that often springs to mind is that of the mischievous, tall, red-and-white-striped feline who turns a rainy day into a whirlwind of chaos.
