These properties make the line segment one of the most reliable and predictable

In coordinate geometry, you might also see the notation **AB** used to denote the length of the segment, which is the distance between points A and B. The length is a positive number and is written without the bar, simply as AB or  $|AB|$ .

When labeling a line segment in a diagram, the endpoints are usually marked with dots or small circles, and the letters are placed near the endpoints. Sometimes a small tick mark is drawn across the segment to indicate that it has a specific length or to show that it is congruent to another segment.

Understanding these conventions helps you interpret geometric diagrams accurately and reinforces the math definition of a line segment.

## The Midpoint of a Line Segment

A special point associated with every line segment is its midpoint. The midpoint is the point that divides the line segment into two equal parts. If you have a segment AB, the midpoint M is the point on the segment that is exactly halfway between A and B. This concept flows directly from the math definition of a line segment because the segment has a finite length that can be precisely divided.

Finding the midpoint is straightforward, especially in coordinate geometry.
