THE FIRST WEEK:

FOUNDATION

Your first week is about orientation to the facility, the unit culture, and the basic logistics of daily work. The new nurse orientation checklist for this period should feel like a roadmap for your first few shifts.

- **Physical layout:** Locate the supply rooms, medication rooms, clean and dirty utility

- **Shift schedules and call-offs:**

Review the process for requesting time off, reporting a sick day, and swapping shifts.

- **Break and meal policies:**

Understand designated break times, how to coordinate coverage, and where staff meals are kept.

- **Dress code:**

Confirm scrubs, lab coat, ID badge, and any specific uniform requirements (e.g., closed-toe shoes, no artificial nails).

Electronic Health Record (EHR) Training

Spend dedicated time learning the electronic health record system. Your new nurse orientation checklist should include specific tasks like logging in, finding patient charts, viewing lab results, entering vital signs,

CLINICAL SKILLS AND COMPETENCY VALIDATION

Medication Administration

Medication Safety

- **Five rights of medication administration:**
Right patient, right drug, right dose, right route, right time. Also include the newer rights like right documentation, right reason, and right response.
- **Pump programming:**
Practice setting up IV pumps, including smart pumps with drug libraries. Learn how to troubleshoot alarms.
- **High-alert medications:**
Review the facility's policy

on insulin, heparin, opioids, and chemotherapy agents.

- **Medication reconciliation:** Understand the process for taking a medication history and updating the home medication list.

Patient Assessme nt and Monitorin g

- **Head-to-toe assessment:** Your preceptor will observe you

performing a complete physical assessment, focusing on system-specific nuances (e.g., lung sounds for respiratory patients, neuro checks for stroke patients).

- **Interpretation of vital signs:** Know age-appropriate normal ranges, when to escalate abnormal vitals, and how to use early warning score systems like MEWS (Modified Early Warning Score).
- **Equipment use:** Demonstrate correct use of pulse oximeters, blood pressure cuffs, thermometers,

cardiac monitors,
and glucometers.

Common Procedures and Skills

Your new nurse orientation checklist should include, at minimum, demonstration of:

- Starting and maintaining IV access
- Blood draw and specimen collection
- Wound care and dressing changes
- Catheter insertion and care
- NG tube placement and feeding

- Tracheostomy care and suctioning (if applicable)
- Code blue response role (review of code cart, defibrillator use)

POLICIES, PROTOCOLS, AND DOCUMENTATION

Understanding the rules that govern your practice is just as important as clinical skills. Your orientation must cover the facility's specific policies.

Key Hospital Policies

- **Infection control:**
Isolation

precautions, hand hygiene protocols, and proper use of PPE.

- **Patient safety:** Fall prevention, pressure injury prevention, safe patient handling and mobility techniques, and use of bed alarms.
- **Code of conduct:** Zero tolerance for bullying, harassment, or discrimination. Understand chain of command for reporting concerns.
- **Informed consent:** Know the nurse's role in verifying consent and witnessing signatures.

Charting and Legal Documentation

Your new nurse orientation checklist should emphasize accurate, timely, and complete documentation. Learn the facility's standards for:

- Nursing notes (narrative, charting by exception, or electronic templates)
- Flow sheets for vital signs, intake/output, and pain reassessment
- Incident reporting: what constitutes an

event, how to document it, and the importance of never altering the original record

- Handoff communication: using SBAR (Situation, Background, Assessment, Recommendation) or a similar structured tool

COMMUNICATION AND TEAMWORK SKILLS

Nursing is a team sport. Orientation is the perfect time to practice interprofessional communication. Your checklist should include activities that build these competencies.

Delegation and Supervision

Understand what tasks you can delegate to licensed practical nurses (LPNs) or unlicensed assistive personnel (UAP). Review the facility's delegation policy. Practice giving clear, concise directions and following up to confirm completion.

Conflict Resolution and

Assertive ness

Role-play common scenarios where you need to speak up, such as disagreeing with a physician's order or addressing a colleague's unsafe behavior. Your orientation should provide a framework for respectful yet firm communication.

Patient and Family Education

Demonstrate the ability to teach patients about their medications, disease processes, and

discharge instructions. Use simple language and the teach-back method to verify understanding.

SAFETY AND EMERGENCY PREPAREDNESS

A dedicated section of your new nurse orientation checklist must focus on keeping everyone safe.

Emergen cy Codes

- **Code Blue:**
Cardiac arrest response – locate the code cart, know your role as a first responder, practice chest compressions and bag-mask ventilation.
- **Code Stroke:**

Rapid identification of stroke symptoms, activation protocol, and transport to CT.

- **Code Sepsis:** Recognize signs of sepsis, initiate sepsis bundle, and administer fluids and antibiotics within the golden hour.
- **Fire safety:** RACE (Rescue, Alarm, Contain, Extinguish) and PASS (Pull, Aim, Squeeze, Sweep) for fire extinguishers. Know evacuation routes.

e Violence Preventio n

Learn de-escalation techniques, how to recognize escalating behavior, and when to call security. Review the facility's response plan for violent incidents.

MENTORSHIP, PRECEPTOR FEEDBACK, AND SELF-REFLECTION

Orientation is not a linear checklist of tasks; it is a relationship-driven process. The quality of your orientation often depends on the strength of the bond with your preceptor

and your own proactive engagement.

Weekly Check-Ins

Schedule regular meetings with your preceptor and nurse educator to review progress. Use the new nurse orientation checklist as a progress tool. Ask specific questions: "I am still struggling with central line dressing changes. Can we schedule an extra practice session?"

Self-Assessment and

Journaling

Transition to Independent Practice

- Handing off care to the oncoming nurse using SBAR without prompting
- Receiving a satisfactory final evaluation from the preceptor and educator
